

## Madison Library Computer Use Policy

### Mission

In keeping with our mission to be an information resource to the community of Madison and recognizing the importance of the internet as an information resource, the Madison Library is committed to providing access to online information resources.

### Internet Access

The internet is an unregulated medium. There is no guarantee for the quality or character of web-based resources. We do not use web filters as these have been shown to impede information searches. This is a reflection of the Trustees' adoption of the American Library Association's "Freedom to Read" policy, which does not limit information available to patrons due to age, sex, or racial background. **Parents are encouraged to supervise their children's browsing if they are concerned about content. All computer users should avoid sites which others in the library may find offensive.**

### Conditions Regulating Computer Usage

1. All users must sign in at the circulation desk.
2. All users must have read this policy before using library's computers.
3. Children under 18 years of age must have a parent's or guardian's signature on a Computer Use Agreement form (see reverse), which is kept on file at the library.
4. Computer use is limited to one hour sessions if others are waiting or at the discretion of library staff. Longer periods may be reserved for special circumstances (i.e. online testing, job applications.)
5. **Do not accept software upgrades when opening web pages, or download software programs when using the library's computers.**
6. Users may print documents at the cost of 15 cents/page.
7. Users may save and send files as email attachments. USB Flash drives may be used to save files at the librarian's discretion.
8. When using audio programs please use headphones. While the library provides headphones, we strongly encourage you to bring your own.
9. Do not bring food or drink to the workstations.
10. **Treat keyboards and mouse attachments gently; do not touch the monitor screen.**
11. Inform the staff immediately if there is a problem with the computers or equipment.

### Wireless Access

The Madison Library has a wireless connection open to public use for internet access. Wireless internet use at the library falls under the **same conditions and courtesies as listed above.**

**Failure to follow these conditions may result in revocation of computer use privileges.**
