REPORT OF THE TREASURER: The board reviewed the Treasurer's Report that was in the board packet. Library Director Sloane Jarell noted that there was an error in the payroll this week so there might be a slight fluctuation in the Budget Drawdown. The Drawdown was at 49.69%, just about on target for this time of year.
