The motion passed 3-0-0 with 3 abstaining. 16 REPORT OF THE TREASURER: Cheryl Littlefield noted that the Treasurer was not present and 17 18 said the Drawdown looks good. Christina McAllister had some questions regarding book purchases, the Technology line, and the Postage line. These issues were discussed and resolved. 19 20 Motion by Linda Smith to accept the Treasurer's Report, seconded by Christina McAllister. The 21 motion passed unanimously and the report was accepted and filed for audit. 22 23 LIBRARY DIRECTOR'S REPORT: Library Director Sloane Jarell: 24 25 26 Agreed with Patti Rau that the Statistics look amazingly good, reflecting a busy summer. • We had a third person come in to give an estimate on the doors. This person said that 27 much more needs to be done than just doors, and we may need a variance. We have not 28 29 received a quote from them yet. • Generator Connection came in to hook up the generator with Sloane's phone: however, 30 they were unable to get this done. They suggested that we acquire a cellular remote 31 monitoring system for an annual fee. Board members expressed dissatisfaction with this 32 and said that the fee should be paid by the company since the contract stated that it 33 would be hooked up to the phone. 34 Programs are going great. There will be a Parent Meet & Greet on October 6 which will 35 be promoted in the school newsletter. 36 One Book One Valley, October 16: The History of Sound by Ben Shattuck. Usually the 37 author speaks at the Majestic Theatre, but since the movie based on the book has just 38 come out, he will be unavailable this year. A contingency plan is being worked on. 39 Denise attended the Back-to-School event at Madison Elementary on August 27 and gave 40 out library information. 41 There will be another Coop meeting in October. 42 43 44 Cheryl Littlefield reminded board members that the budget is due at the end of October and will 45 be discussed at the next meeting.
